### Competition details

<b>Promotion Name</b>	Slasher Organic Weedkiller Spring Giveaway 2021
<b>Promoter</b>	The Promoter is Organic Crop Protectants a division of DuluxGroup (Australia) Pty Ltd (ABN 67 000 049 427) of 1956 Dandenong Road Clayton, VIC 3168.
<b>Promotion Type</b>	Game of skill
<b>Promotion Period</b>	The Promotion will commence on 15 September 2021 and close on 15 October 2021. <b>(Promotion Period)</b> .
<b>Entry Restrictions</b>	<p>This promotion is only open to residents of Australia, for purchases made in Australia. Entrants under 18 years of age must get permission from a parent or guardian before entering. Employees (and their Immediate Families) of the Promoter, the Participating Store or any of their respective parent companies, subsidiaries or affiliated companies, or any agencies associated with this promotion are ineligible to enter. "Employees" means any directors, management, employees, concessionaires, consultants, officers and contractors or other such people who perform work under the control of another in exchange for payment. It can be anything from a nice product shot, a photo of Slasher being used or even the results of using Slasher on your weeds.</p>
<b>Additional entry requirements</b>	<p>Any entry that contains content that the Promoter, in its sole discretion, considers to be offensive or inappropriate in any way or that the Promoter considers, in its sole discretion, to infringe any intellectual property rights or other rights of any person, property, corporation or entity, will be considered ineligible. Judging will commence on 21 October 2021. Five individual entries (one from each of the following state groups: New South Wales/ACT, Victoria/Tasmania, Queensland, South Australia/Northern Territory and Western Australia), in the opinion of the judges, will be selected from the final entries received, and judged as winners.
